The Town Board of the Town of Cottage Grove does ordain as follows:

TCG Ord. Section 20.02 Offenses Against Animals is hereby amended to read as follows:

#### 20.02 OFFENSES AGAINST ANIMALS

### (1) STATE STATUTES INCORPORATED BY REFERENCE

The following statutory references following the prefix "20", are adopted as offenses under this ordinance; provided the penalty for the commission of such offenses shall be limited to a forfeiture imposed under s. TCG 25.04. The following Wisconsin Statutes defining offenses against animals are hereby adopted by reference. Any future amendments, revisions or modifications of the Wisconsin Statutes incorporated herein by reference are intended to be made part of this Code of Ordinances. The penalty for the commission of such offenses shall be limited to a forfeiture imposed under s. TCG 25.04. For convenience, ordinances incorporating the Wisconsin Statutes may be referred to using the prefix "20" and the Wisconsin Statute. That is,

TCG Ord. Section 20.03 is hereby renamed to Other Animal Regulations and amended to read as follows:
20.03 ANIMAL HEALTHOTHER ANIMAL REGULATIONS
(1) [Text to be developed.] OWNERS OR CUSTODIANS TO CONTROL ANIMALS.
(a) An owner or custodian of an animal shall not permit, whether negligently or otherwise
the animal to run at large. An animal is considered to be running at large if it is off the premises
of the owner or custodian and not under the control of the owner or custodian.
(b) When an animal is off the property of its owner or custodian, the owner or custodian shall
(c) <u>not permit, whether negligently or otherwise, the animal to attack, bite or otherwise injure:</u>
1. any other domestic animal;
2. any person who is engaged in a lawful activity.
(2) PENALTY FOR VIOLATION
Any violation of this section shall be subject to a Class D forfeiture as specified in TCG Ord
25.04(1)(b). Each and every day such violation occurs shall be considered a separate offense.
