ORDINANCE REPEALING JOINT CGPD AND LEC AND AFFIRMING SERVICES BY DCSO

WHEREAS, effective at 11:59 p.m. of December 31, 2014, the Town of Cottage Grove and Village of Cottage Grove terminated the joint police department, thereby eliminating the need for Town Code 04.01 "Police Department – Creation, Duties and Powers" and Town Code 04.05 "Law Enforcement Committee," copies of which are attached as Exhibit B for reference;

WHEREAS, effective January 1, 2015, police protection in the Town of Cottage Grove is provided by contract with the Dane County Sheriff's Office.

NOW, THEREFORE, THE TOWN BOARD OF THE TOWN OF COTTAGE GROVE ORDAINS AS FOLLOWS:

1. Town Code 04.01 "Police Department – Creation, Duties and Powers" and Town Code 04.05 "Law Enforcement Committee" are hereby fully repealed and shall be of no further force or effect.
2. Town Code 04.01 is created to read as follows:

**04.01 POLICE PROTECTION SERVICES**

The Town shall provide police protection services to its residents by contract with the Dane County Sheriff's Office (DCSO), on such terms and conditions as are approved by the Town Board. The Town hereby affirms that officers and deputies of the DCSO have jurisdiction to provide law enforcement services in the Town of Cottage Grove, all in accordance with law.


3. Town Code 04.05 is hereby reserved for future use.
