

**TOWN OF COTTAGE GROVE
TOWN BOARD RESOLUTION NO. 2021-11-01**

ADOPTING A WARD PLAN

WHEREAS, Wis. Stat. §5.15, requires all cities, villages, and towns with a population of 1,000 or more to establish municipal wards based on the results of the decennial census; and

WHEREAS, Wis. Stat. §59.10(3)(b) requires that each county board adopt and transmit to each municipal governing body in the county a tentative county supervisory district plan; and

WHEREAS, the Dane County Board of Supervisors has submitted such a tentative Dane County Supervisory District Plan to the Town of Cottage Grove; and

WHEREAS, the Wisconsin Statutes require that each municipality designate by consecutive whole number, geographical description, and population the various wards to be created within the municipality;

NOW, THEREFORE BE IT RESOLVED, that the Town of Cottage Grove adopts the wards described as follows:

Ward Number	Description	Population
1	North Central	588
2	North West	388
3	West Central	374
4	N. East/N. Central	923
5	S. East/S. Central	541
6	South West	977

BE IT FURTHER RESOLVED that the ward boundaries are outlined and identified on the attached map, which is incorporated as Exhibit A and made a part hereof. The map is generated using WISE-LR software in order to incorporate the underlying census block numbers within each ward, which are identified in the attached Exhibit B, which is incorporated and made a part hereof.


BE IT FURTHER RESOLVED that all six wards are hereby combined for voting purposes, so as to share a common polling place at the Town Hall, 4058 County Road N, unless otherwise assigned by resolution of the Town Board, and such combined wards shall use common voting machines and separate returns shall not be maintained for the combined wards at any election unless otherwise required by law.

BE IT FURTHER RESOLVED, that upon passage, a copy of this resolution shall be filed with the Town Clerk, who shall transmit a copy of the ward plan and this resolution to the Dane County Clerk within five days of its adoption.

BE IT FURTHER RESOLVED, that this resolution shall remain in effect for each election until modified or rescinded in accordance with Wisconsin Statutes, or until a new division is made following the next federal decennial census.

This resolution was duly considered and adopted by the Town of Cottage Grove Board of Supervisors pursuant to a vote 5 for and 0 against and 0 abstentions on this 1st day of November, 2021.

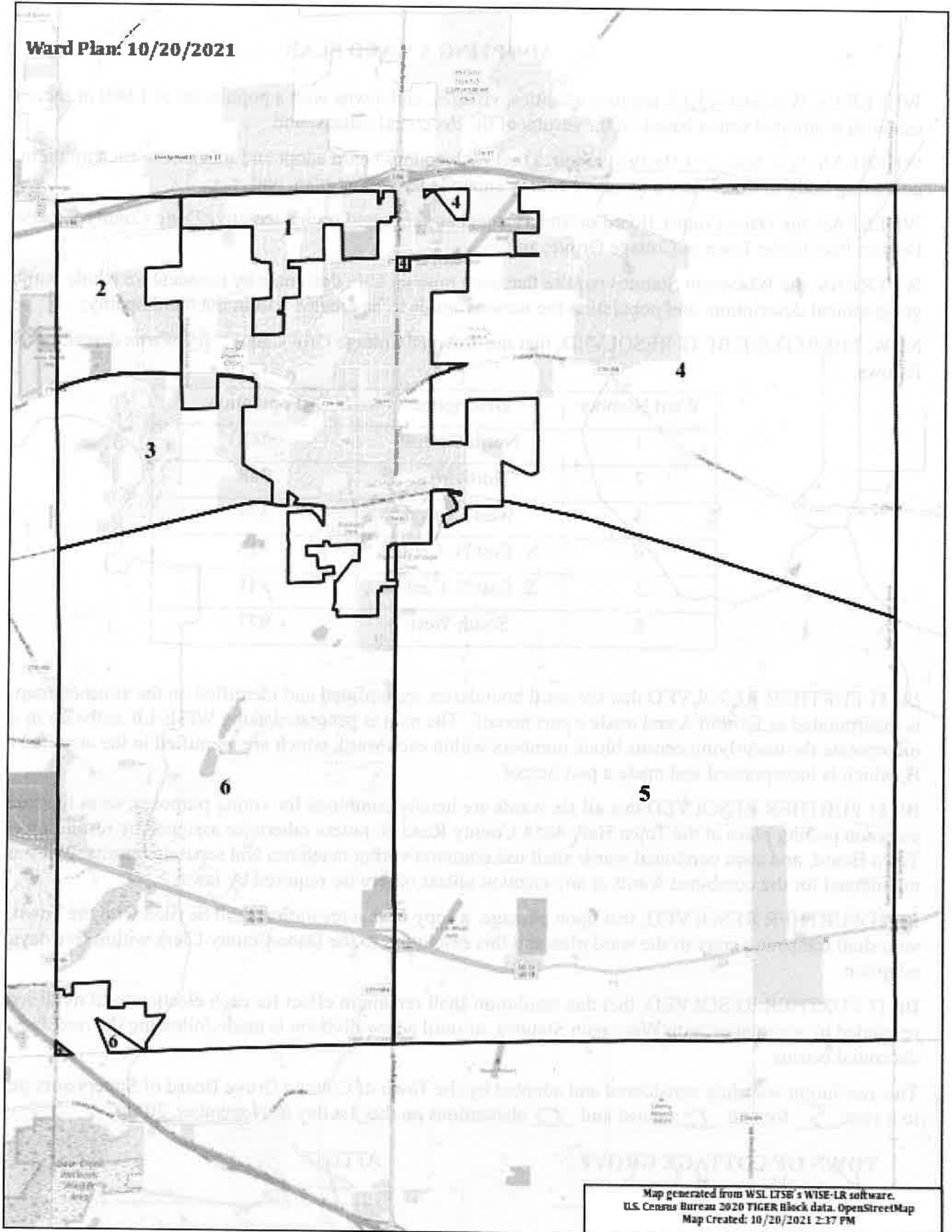


